A. FINANCE

Mr. Slade reported that Durand State Bank confirmed the Village accounts are protected by pledged securities. There will be a Special Board Meeting April 29th at 6pm to Review/Amend the Budget. Economic Interest Forms are due by 5/1/19. Mr. Slade read the tax revenues aloud.

B. ECONOMIC DEVELOPMENT

Mrs. Hoffman is absent so no website update. There was a complaint that the Disc Golf Baskets were too close (20 ft. away) to the parking area, but after measuring, the complaint was inaccurate. The baskets are 60 ft. away from the parking area and that is standard.

C. BUILDINGS AND PARKS

Mr. Kahl is looking into Ball Park Lighting pricing.

D. STREETS AND ALLEYS

Mr. Kahl reported he has 30% of the street patching left to do. This should be completed tomorrow, weather depending. The South St. curbs are in need of repair but they are the County's responsibility so there's nothing Mr. Kahl can do. He advised everyone to maybe contact Jim Webster @ (815)988-2701 to get something done about it. Tree and shrub setbacks were discussed. It was agreed upon that any new vegetation with full growth expectation of 3.5 ft. or taller (new plantings only) should take place at least 10 ft. from the property line. Chief Schelling provided a map of the Bulldog Bolt 5k Route for the Board to review.

E. WATER AND SEWER

The test well came back good this time. The Board conducted a straw poll yielding 5/0 in favor of moving forward with the well project at the new location in Saelens Park. The South and State Street water mains project will start at Center St. and head east to Medina (starting next week April 29th, weather depending).

F. POLICE

The money for the Crime Stoppers Luncheon (May 15th), if anyone wants to attend, is due by April 30th. May 13th-19th is Police Memorial Week. May 17th-19th there will be displays set up at Cherryvale Mall. Also, May 17th there is a breakfast at Tebala Shrine Events Center.
