## **ZONING**

Zoning administrator John Scott presenting concerns that are currently being addressed by the zoning board

- There is a request to vacate 2 alleys in the Village. The first between W
  Washington St and 110 W Elm St. The second between W Elm and 202 N Center
  St. The paperwork is being put together by Mr. Scott so an ordinance can be
  drafted.
- 2. Cannabis Zoning Guidelines are being studied. Once the state sets these guidelines The Zoning Board can finalize Village guidelines.
- 3. Solar Panels are being taken more seriously now by the County since residents are now interested in installing these. Many guidelines are involved in the installation of these, including who is certified to install them and Winnebago County does require a permit to do so.
- 4. The flood map CD has been located and given to Sherry. They are working on making a large map for the Village.

# **PUBLIC COMMENT**

Ken Opperman addressed the board regarding the water hookup for 505 E North Street. The last active personal well in the Village is located on this property and the owner was informed of the need to connect the house to the municipal water supply. Mr. Opperman is asking that the board waive the hookup fee.

## **COMMITTEE REPORTS**

#### FINANCE

Kyle Demus went over the annual audit report. The Cannabis tax is up for a vote today on unfinished business. The tax is set at 2.75%. Surrounding communities have set this tax at 3%. The zoning board is also discussing cannabis. A check was reissued to Rockford Communications for 2018 invoice #1056 in the amount of \$75.78. The payment was not received by them and was not posted by the bank.

## STREETS AND ALLEYS

Civil returned twice to sweep the excess gravel on the streets covered by chip seal. There was about 60 yards of gravel collected. The board discussed the IEPA Loan Disbursement #6 for the South and State Street Water Main Project

#### WATER AND SEWER

A possible waiver for the water hookup for 505 North Street was discussed. The South and State Street water main project change order regarding the Kelsey Contract extension was also reviewed. Five water meter pits will need to be installed for the apartment building on Newman Street. The flooding caused by the recent rains and subsequent ground saturation has strained the drainage system and caused the sewer system to backup in many residences. The use of sump pumps in many homes has made the situation worse. A future possible ordinance, which will prevent the use of these pumps in homes, was discussed.

## POLICE

The homecoming parade will be held on September 27th starting at 2:30. Chief of Police Jeff Schelling has been in RMS training for 3 days.

- **F.** The Kelsey completion date extension is a redundancy and will be removed. It again explains that the Water Main Project Contract will be extended by 12 days.
