COMMITTEE REPORTS

A. FINANCE

A 1% sales tax was discussed as a means to pay for the upcoming projects to improve water quality. Legal will be working on the proposal to get it on the upcoming ballot. Animal control has been cutting services and is charging the Village a flat rate of \$3,000. Mayor Corwin has been trying to reach out to animal control to discuss the matter. The board of trustees will go into executive session to discuss updating wage packages for Village employees.

B. ECONOMIC DEVELOPMENT

Aaron Kahl, the Public Works Supervisor, spoke with Mick Gronewold of Fehr Graham about the Square Project. Plans for the project will be sent to IDOT by the end of next week. There's no way to know when IDOT will grant approval. Dollar General is still working with IDOT regarding the plans for a store to open in the lot north of the bank. Everything seems to be on track at this time.

C. BUILDINGS AND PARKS

AJ Becker of Sonic Spectrum has proposed to provide fiber optic internet service for the village at \$450.00 per year, which is approximately half the cost of the current service. This matter is in the bills tonight for approval.

D. STREETS AND ALLEYS

Details were discussed for the Stateline Classics Car Show which will be held on June 21st. The school will allow usage of their parking lot if needed. Address changes were discussed for some properties on East Howard St. These may be changed to Oak Street addresses. MFT Street Maintenance IDOT resolution is up for a vote tonight. Funds will be used to resurface both of the parking lots in the park and for other street repairs.

E. WATER AND SEWER

Funds were received for the South and State water mains project. The EPA has required that drinking water be tested daily as opposed to the previous requirement of monthly

testing. The samples will need to be delivered to Rockford at a cost to the Village that has yet to be determined.

F. POLICE

Chief Schelling and Sergeant Sigmund are both attending a Train the Trainer class in District 3 in Rockford on Friday January $31^{\rm st}$. AJ from Sonic has been in contact with County to get the village connected to fiber optic internet. Chief Schelling attended an NWILEAA Retreat on Monday January $20^{\rm th}$ in Galena.
