A. FINANCE

The proposed 1% sales tax was further discussed and is still with legal. Trustee Slade recommended a retail at sale and service sales tax. January financial statements were handed out and reviewed. The DCEO grant in the amount of \$85,000 was received by the Village to help cover remaining costs incurred by the square project. The utility clerk/office assistant wage will be discussed in executive session.

B. ECONOMIC DEVELOPMENT

The Charm update was provided and reviewed to the board. The community dinner will be held Saturday February 29th at the school. This event is expected to sell out. Tickets are available at the Charm office in the village hall and online at durandcharm.com. Winners of citizen of the year and business of the year will be announced at the event. E. WATER AND SEWER

Bids for the well project are going out. A resident at 801 E Elm Street is asking that the months of December and January of his water bill be waived as there have been no occupancy at his house. He states he forgot to call the village to have it shut off. The general consensus among the trustees is to deny his request, with Mr. Slade stating that it would set a precedent.

F. POLICE

The monthly report for January was handed out. Chief Schelling spoke with Wendy Bennett who is part of the group supporting the ½% tax for mental health services in Winnebago County. She wants to put signs up. Chief Schelling spoke with John Scott about where they could go. Wendy will be attending the February 24th board meeting to speak about the tax. Windows 10 could not be installed on one squad's Mobile Data Terminal because the squad is outdated at 11 years old. Windows 10 is preferred for the new CAD/RMS system. Chief Schelling emailed the IT Project Manager asking if Windows 8.1, which the squad is currently equipped with, would be acceptable. If not, Chief Schelling will need to look into purchasing a refurbished MDT and bringing the cost to the next board meeting.
