COMMITTEE REPORTS

A. FINANCE

The Village budget was looked at and the 1% sales tax proposal was discussed. A Declaration of Emergency was handed out and will be voted on tonight.

B. ECONOMIC DEVELOPMENT

Economic Interest Forms must be filled out by the end of May and it is encouraged they be filled out online. They can also be dropped off at County. Durand Charm is interested in having an enclosed one-day beer garden at their Fall Festival. The consensus of the board is to move forward with this. Proof of Insurance, with the Village listed as additional insured would be required as well as a dram shop insurance policy. Mayor Corwin will work with Village Attorney Darron Burke and Durand Charm on this. More information on this will be available at the next meeting. Updates to the website include: Village Board agendas and minutes, County Building Permit form, COVID Village and State, Trash procedures affected by COVID, and updates to Village emails. The Village Hall is currently closed, with Sherry Bessert working from home.

C. BUILDINGS AND PARKS

The board discussed the proposed memorial bench for Larry Clark. The village would initially pay for the bench and would be reimbursed.

D. STREETS AND ALLEYS

Public Works has been fixing alleys. They will start filling potholes as soon as weather permits. Public Works is also looking into obtaining a walk behind street sweeper at an estimated cost of \$3,500. Mayor Corwin suggested a possible rental and Aaron Kahl is going over the numbers to see which option would be more cost effective. March 31st is also the bid opening for streets, at 11 a.m.

E. WATER AND SEWER

Bid opening for the well project is March 31st at 10 a.m. The board will hold a Special Meeting discussion on April 3rd to vote on the bids.

F. POLICE

The Crime Stoppers Luncheon, which was scheduled for May 14th has been cancelled as a precaution against the spread of COVID. NIBRS training, scheduled for March 26th

and 27th has also been cancelled. Police Service has been modified to protect the health of the Village Officers. The food drive held by the Durand Ecumenical Council is scheduled for April 4th.

UNFINISHED BUSINESS

A. A straw poll showed the board in favor of granting the one-day Beer Garden License to Durand Charm.
