A. FINANCE

April financial statements were handed out and discussed. 1% Sales Tax is still being discussed and is in the planning stages. \$1,289,560 in grants are available for a project estimated to cost \$1,746,950. A Bond Resolution to cover the remaining balance of \$457,390 will be discussed and voted on at the next board meeting. The annual audit is scheduled for the week of June 22nd.

B. ECONOMIC DEVELOPMENT

Market in the Park has been cancelled due to COVID. Charm is discussing transferring the vendors to harvest fest. The June 12th and July 10th movie nights have also been cancelled. Charm is still hoping to hold the movie night scheduled for August 7th. Dash for Trash has been rescheduled for June 27th. The duck race will still be held, as 10 people are not required to hold this event. Tickets are on sale at the Firebarn and online.

C. BUILDINGS AND PARKS

Chief Jeff Schelling and Public Works supervisor Aaron Kahl have both said that they have not had any problems with crowds at the park. Dollar General has begun construction on their store next to the bank.

Village President Bob Corwin has stated burning of yard waste can resume from today's date to the end of May. The Village Board all agreed to this schedule. Street sweeping is complete.
