COMMITTEE REPORTS

A. FINANCE

Sherry handed out a sheet listing the cost breakdown of copier use. The copier at the office is becoming old and may need replacement soon. A grant was given to the Village in the amount of \$15,849.90 by the state to be used for infrastructure improvements. The Village can expect to receive a check twice a year for the next three years as part of the Rebuild Illinois program. Dan Pepin was present via teleconference to discuss the Fast Track Grant which could be used for the upcoming water project. This grant application must be for a minimum of \$500,000.00. Pepin Suggests roadway projects also be included.

B. ECONOMIC DEVELOPMENT

Dollar General is currently under construction and is coming along. Restaurants and bars will be opening for outdoor dining on May 29th. Representatives for Ref's, Firebarn, Hogs and Hydrants, and Ringo's discussed with the board ways that they could effectively open while following state guidelines. Firebarn asked to use the alley between their business and the Masonic Temple for additional seating, if needed. Ref's will be using the lot next door, with permission from the owner, to set up an additional seating area, extending the existing beer garden, Hogs and Hydrants have made improvements to their beer garden to accommodate additional outdoor patrons. Ringo's questioned where their customers would be allowed to park. It was agreed that they would be allowed parking on South Street, across from the restaurant.

The Zoning Board needs another member, as Deb Jones has retired.

E. WATER AND SEWER

IEPA disbursement for the Water Mains Project is \$77,080.33. There may be another payment in the future but will be small in comparison. The board is addressing Zoning issues that have arisen with the county office. The Lift Station Pump went out but was back up after a simple repair was performed by Aaron Kahl.

F. POLICE

The parade for graduating high school seniors was held on May 17th at 2 p.m. It started and ended at the school. Two additional cameras may be installed at the park in the future. This item is tabled for now. Grass on the pavement is a violation of the Litter Control Act and is a safety hazard for anyone riding motorcycles or bicycles. Mrs. Hoffman will be updating the website with information regarding this issue. A statement will also be published in the Volunteer. Birthday drive by parades will be suspended as of June First. The Police Department put together a total of 50 birthday parades. Chief Schelling received a grant from Country Insurance in the amount of \$1,500 which will be used for updated equipment.
