A. FINANCE

Cannabis Business Zoning Ordinance was recommended for adoption by the Zoning Board and is on the agenda for a vote tonight. The Village Attorney is working on the TIF Agreement for 408 Center St. The deadline for reporting of ARPA funds was moved to April 30, 2022. IML is lobbying for an increase in charges for video gaming terminals in non-home rule communities. Mr. Burke discussed IMRF Election dates and timelines.

B. ECONOMIC DEVELOPMENT

Trustee Clark provided an update on the Subcommittee for Business Development. A.C. McCartney Pre-annexation was discussed by the board members. Halloween on the Square will be held on October 30th from 10-12.

C. BUILDINGS AND PARKS

Trustee Slade provided information about vacant property registration, or PROCHAMPS. Water will be shut off at the park soon. Kelly Giovanine is helping to sell items found in the Norder Shed.

D. STREETS AND ALLEYS

The Square Project will go out for bid on November 5th. Street patching will start this week for North, Elm and Pepper Streets, and next week for Patterson and Pepper Rd. resurfacing.

E. WATER AND SEWER

The Village has come to an agreement with a resident concerning a private well on his property. The new well being built as part of the Well Project could possibly be done in a month. Well #3 will be done in the spring.

F. POLICE

The Prescription Drug Drive will be held at Durand State Bank on November 13th from 9-11 a.m. The Trustees discussed a possible amendment to the liquor Ordinance, which would lower the age to scan to 18.
