A. FINANCE

October financials were handed out and discussed. The proposed Bond Financing for the Square Project was discussed, with the addition of a ten-year payoff period. The Village Budget Timeline was handed out and reviewed. Proposed Changes to Raffle Licenses were discussed. The Sonic Spectrum phone bill will have a simplified scheduling structure in the future. A straw poll reflected a 5-0 approval (with 1 Trustee being absent) to upgrade the Civic Accounting System with an online Payment Processing Add-On.

B. ECONOMIC DEVELOPMENT

Halloween on the Square and the Ribbon Cutting Ceremony went well and were well attended. Repairs to the gazebo in the Square were discussed, as well as a possible rebuild of the structure. DARTS and Durand C.H.A.R.M. both have Raffle requests on the agenda for a vote tonight. A non-binding advisory question regarding raising chickens within the Village will be put on the April election ballot to gauge Village interest.

C. BUILDINGS AND PARKS

All three buildings of the Otter Creek Farm have been condemned by Winnebago County and the owner will clean the fence line.

D. STREETS AND ALLEYS

Snow Removal and salt usage guidelines will be provided to the business owners on the Square. Most of the railings have been installed on the West Side of the Square. The Railings should be finished in the next couple of weeks.

E. WATER AND SEWER

Trusses should be up on Well #3 within two weeks. Letters will be sent out to inform homeowners that lead was detected in two homes in the Village. There are no lead service lines in the Village. Two samples have been taken and the Village is awaiting the findings.

F. POLICE

The monthly Police report was handed out and discussed. A request to provide a discounted solicitors permit for D.A.R.T.S. members was discussed by the board members and has been passed to Village Legal.
