They will also organize a meet the candidates forum in mid-March for those running for Village Board. Plantings on the Square should take place by Mid May. A shred event, organized by Mayor Hoffman and Senator Chesney, will take place at the West School Parking Lot on June 10th from 9 a.m. until noon.
