COMMITTEE REPORTS

A. FINANCE

A special meeting has been scheduled for Monday April 29th at 6:00 p.m. to discuss the budget for the 2025 Fiscal Year. Bond documentation is due by May 2nd and will be sent out this week. The Village has been given a 4.32% interest rate. The utility clerk position has not been filled yet. Statements of Economic Interest is due on May 1st. TIF agreement applications are out for 101 E South St., 419 Center St., and 202 Center, which has been completed.

B. ECONOMIC DEVELOPMENT

The Village Library has had a good turnout for their monthly programs. The Summer Reading Committee met on April 18th and had been working on plans with the collaboration of Principal Rufener. Economic Support Mapping groups have been meeting regularly. The WREX coverage that was coordinated by Charm in January for Destination Downtown was aired. Ringo's has 5 dates set for car shows-May 28th, June 25th, August 6th, August 27th, and September 3rd. The Legion will hold a home show on April 27th. Village Wide garage sales will take place April 26th- 28th. The stop and swap will take place at the Durand Methodist Church from May 1st through the 4th. The Market in the Park, the spring plant sale and Dash for trash is scheduled for May 4th. Durand PTO has requested waiver of Bond for a silent auction to be held in conjunction with Market in the Park and the 5k on May 4th. A straw poll showed unanimous support.

C. BUILDINGS AND PARKS

The Public Works Building should be completed by early June. Damage to the Disc Golf course has been reported and cameras will be installed to monitor the area.

D. STREETS AND ALLEYS

The building at 417 Center St was inspected by Randy Ketchum and Trustee Dasko. A letter listing noticed violations will be sent to the owner.

E. WATER AND SEWER

The main lift station project will be completed when the pumps are picked up. Upon completion and closing of the Main Lift Station Project the IEPA will report and advise on the possibility of a potential rate increase.

F. POLICE

Steve Sager took the Oath of Office as a full time Durand Police Officer. Body Worn Cameras were delivered and will be installed soon. Chief Reiman will attend the ILACP Annual Training Conference in Tinley Park from April 24th-April 26th. The Board discussed increasing the pay for part-time officers to \$25 per hr. and no change would be needed in the budget to implement this change.
