Village legal will look into creating an Ordinance. The Board moved to have a Resolution written for the approval of the use of ARPA funds. Trustee Slade will keep the board updated on HB4169.

B. ECONOMIC DEVELOPMENT

Kelly Giovanine provided a Durand C.H.A.R.M. update. The Square Project Business Meeting will be held at Solutions Bank on February 22nd at 3 P.M.

C. BUILDINGS AND PARKS

The Trustees discussed forming a board for a Park District. Fees for special events was discussed. The Board Members compared the Forest Preserve Price Structure to similar Village needs.

D. STREETS AND ALLEYS

Mayor Hoffman met with Fehr Graham to discuss options of a multi-use path that would start at Ruby St. to Cameron Dr., connecting to the path at Saelen's Park and back to the Center St. Bridge. The speed limit would be lowered to 35 mph along Center St. HB5281 would create a license plate for UTV'S, which would make them subject to similar laws concerning other types of vehicles. The board discussed the street parking Ordinance, but is waiting for details from County so it has been tabled for now.

E. WATER AND SEWER

IEPA Loan Request #11 is on the agenda for a vote tonight. The new well should be operational as of the first week in March.

F. POLICE

The monthly Police Report for January was handed out and discussed. The purchase of the new Squad Car is on the agenda for a vote tonight. Six handlers from 5 different K9 units came through to inspect the Junior and Senior High School. Nothing was found. A handout was reviewed concerning body cams. Chief Schelling and Trustee Becker will be meeting with Dan O'Shea to discuss the I.T. aspects. The Board gave Chief Schelling authority to sign for the IGA Winnebago/Boone County Integrity Task Force.
